If there is more than one authority, please describe allocation of responsibilities. | <p>The Commissioner of Competition is the official responsible for the administration and enforcement of the Act, including merger enforcement, pursuant to section 7 of the Act. The Mergers Branch of the Competition Bureau is responsible for the conduct of merger reviews and is headed by the Senior Deputy Commissioner of Competition. The Competition Tribunal, an adjudicative body that operates independently of any government department, is the specialized court that determines, on application by the Commissioner of Competition, whether a proposed merger is anti-competitive. It determines and orders the appropriate remedy.</p> |
